Sharon Newsom asked about policy JICA, Student Dress Code. There was a note that the School Board needed to decide what Punishment was for the third offense. Chris stated that the handbook does not follow these guidelines so he will change the Policy to align with the student handbook.

### Education Reports:

A. Elementary/Middle School Principal Report (stated report was in the packet)

Mr. Albers highlighted items from his report in the packet. Current enrollment in the elementary is at 179 with a new 2<sup>nd</sup> grader starting tomorrow. Attendance rate continues to be excellent in both the elementary and middle school. Parent Teacher conferences went well. The middle school conferences were held in the Warren Mitchell Event Center which seemed to go very well. In the spring they will probably use the commons and/or the cafeteria because of basketball in the event center. The elementary teachers are still trying to contact parents that did not come to conferences. Teachers will begin the second round of DIBELS testing. The 3<sup>rd</sup> graders will be taking the CogAT test next Monday and Tuesday. This is an assessment to evaluate gifted and talented students. Last Friday all the teachers came together to begin work on aligning the new Colorado Content Standards. The Scholastic Book Fair was again a success bringing in about the same amount as last year. Each elementary teacher received \$117 worth of books. The elementary raised \$350 dollars for the Lincoln County Angel Tree gift program. He thanked Erin Younger, Mardelle Martin and Pam Albers for all of their work to make the Book Fair a success.

B. High School Principal Report (stated report was in the packet)

Mr. Selle highlighted items from his report in the packet. Current enrollment in the high school is 161. Attendance is down from last month due to illness and other events. There was a good turnout for the secondary Parent/Teacher conferences. 120 middle and high school parents attended. He included some samples of the 21<sup>st</sup> Century Skills curriculum alignment. Five schools attended the November 1<sup>st</sup> College Fair. Limon students had a bingo card and needed to talk to four schools and ask them five questions each. The PLAN test was moved to November 16<sup>th</sup>.

**Board Reports:** Jason asked if Chris had heard back from Centimark about the elementary roof. Chris stated that they will honor the warranty. They are going to apply a product to see if they can cover up the spots or they may need to reapply to the whole roof.

**Superintendent's Report:** Mr. Selle highlighted items from his board report. The good news is that there appears that there will not be a mid-year correction to the State budget but that Governor Hickenlooper is asking for \$89 million in cuts from K-12 for 2012-2013. This will be about a \$70,000 cut from Limon's funding. This amount will likely change. He was surprised how bad Proposition 103 failed. Also, the majority of Mil Levy elections did not pass. Most of the ones that did pass were related to the BEST grant. The Neenan group visited the school on October 24<sup>th</sup>. Tomorrow there will be a meeting with the key decision makers from 12 to 3, then with the staff from 4 to 5:45, and then the community from 6 to 8pm. Lieutenant Governor Garcia will be here next Monday to discuss early childhood literacy. The final check from the insurance company for the July 4<sup>th</sup>, 2010 hail storm was received. He is recommending Kim Trujillo as concession manager. The heat exchanger went out over the art room. The warranty ended 9 months ago but Plains Heating convinced Lennox to honor the warranty and replace it.

**Revised Policy JFBB-R**

Jack Horner moved and Sharon Newsom seconded the motion to approve the 1<sup>st</sup> reading of revised policy JFBB-R, Inter-District Choice/Open Enrollment, as presented. Chris stated that this was the regulation. The motion passed unanimously.

Bart O'Dwyer moved and Russell Lengel seconded the motion to approve the coach as presented, Dan Blackwelder as assistant high school wrestling coach. The motion passed unanimously.

**School Closure**
